Victims of Criminal Activity: U Nonimmigrant Status

The U nonimmigrant status (U visa) is set aside for **victims of certain crimes who have suffered mental or physical abuse and are helpful to law enforcement or government officials** in the investigation or prosecution of criminal activity.

You qualify for U Visa if you are...

- A victim of qualifying criminal activity.
- Suffered substantial physical or mental abuse as a result of having been a victim of criminal activity.
- Have information about the criminal activity.
- You were helpful, are helpful, or are likely to be helpful to law enforcement in the investigation or prosecution of the crime.
- Are admissible to the United States.
- And if the crime occurred in the United States or violated U.S. laws.

U Nonimmigrant Visa: What Immigrants Must Know

1

Your relatives may qualify for a U Visa depending on their relationship with you.

2

If you, the principal and are under 21 years of age, you may petition on behalf of your spouse, children, parents and unmarried siblings under age 18.

3

If you are 21 years of age or older, you may petition on behalf of your spouse and children.

4

The limit on the number of U visas that may be granted to principal petitioners each year is **10,000.**
