## Victims of Human Trafficking: T Nonimmigrant Status

T nonimmigrant status is a temporary immigration benefit that enables certain victims of a severe form of trafficking in persons) to remain in the United States for an initial period of up to 4 years if they have complied with any reasonable request for assistance from law enforcement in the detection, investigation, or prosecution of human trafficking or qualify for an exemption or exception.

## Eligibility for T Nonimmigrant Status

#### YOU ARE A VICTIM OF A SEVERE FORM OF TRAFFICKING.

YOU ARE PHYSICALLY IN: THE U.S., NORTHERN MARIANA ISLANDS, OR AMERICAN SAMOA, OR A PORT OF ENTRY.

YOU COMPLIED WITH ANY REASONABLE REQUEST FROM A LAW ENFORCEMENT AGENCY FOR ASSISTANCE IN THE INVESTIGATION OR PROSECUTION OF HUMAN TRAFFICKING.

YOU WOULD SUFFER EXTREME HARDSHIP INVOLVING UNUSUAL AND SEVERE HARM IF YOU WERE REMOVED FROM THE UNITED STATES.

YOU ARE ADMISSIBLE TO THE UNITED STATES (IF YOU ARE NOT ADMISSIBLE, YOU MAY BE ELIGIBLE FOR A WAIVER OF CERTAIN GROUNDS OF INADMISSIBILITY.

# Cambiando Vidas TVisa: What Immigrants Must Know

### THERE IS A LIMIT TO THE NUMBERS OF T VISAS THAT CAN BE ISSUED

The available T nonimmigrant visas for principal victims are 5,000 visas per fiscal year. The victim's qualifying family members do not count towards this annual cap.

### THE REQUIREMENTS YOU HAVE TO SUBMIT IN APPLYING FOR T VISA

 FORM I-914, APPLICATION FOR T NONIMMIGRANT STATUS
 FORM I-914, SUPPLEMENT B, DECLARATION OF LAW
 ENFORCEMENT OFFICER FOR VICTIM OF TRAFFICKING IN PERSONS
 RECORDS OF YOUR COMMUNICATION WITH LAW

ENFORCEMENT, TRIAL TRANSCRIPTS, COURT DOCUMENTS, POLICE REPORTS, NEWS ARTICLES, AFFIDAVITS, OR OTHER RELEVANT CREDIBLE EVIDENCE (OPTIONAL)

✓ EVIDENCE TO SHOW THAT YOU MEET ALL OTHER ELIGIBILITY REQUIREMENTS

✓ EVIDENCE TO DEMONSTRATE THAT YOU ARE ADMISSIBLE ✓ FORM I-192, APPLICATION FOR ADVANCE PERMISSION TO ENTER AS A NONIMMIGRANT SEEKING A WAIVER OF APPLICABLE INADMISSIBILITY GROUNDS, (IF YOU ARE INADMISSIBLE)

A divorced woman traveled to the U.S. to work as a housekeeper to earn and win back the custody of her children.

But later on, she realized that she was tricked by her alleged employer and instead of working as a housekeeper, she was forced to work in hotels and massage parlors and perform sexual acts. The job offer was a complete fraud and an obvious example of human trafficking.

She's not able to reach for not knowing how to speak in English and so, her traffickers took advantage of it and controlled every aspect of her life.
